

Terms, Conditions & Disclaimer

The Party Parlour prides itself on providing a first class party service & for this to happen we need a smooth transition between parties. The host will have access to the Party Parlour **ten minutes** prior to your party start time. This ensures that the Parlour is set for your arrival

We also ask our guests to kindly leave the Parlour promptly in order for a smooth transition to happen.

We thank you in advance for your cooperation.

We require 50% deposit at time of booking or 3 months prior to party date.

Outstanding balance is due 14 days prior to party.

We aim to have finalised party details (final numbers, allergies, required party games etc) with the host, 14 days prior to your party date to ensure all guests are catered for.

2 extra guests free of charge only apply to weekday party bookings, term time only.

Military discount cannot be used in conjunction with any other offer.

There is a maximum of two siblings, under the age of two years, free of charge.

We will ask for a refundable damage waiver deposit when guests are over 18years.

We/the artist - refers to Little Poppets Party Parlour's staff.

You/your - refers to the customer/client and or their parent/guardian

Host – refers to the person who booked Little Poppets Party Parlour

We reserve the right to refuse, to paint or apply glitter tattoos to:

- Any person that appears to be suffering from any kind of skin disorder
- Any children under the age of 3 years

While we take extreme care with all aspects of glitter tattoos, we cannot accept any liability for any adverse reaction to the glue or glitter tattoos. Should sensitivity be a potential problem, you should let the artist know as soon as possible (at least 30 minutes prior to being applied). At this time a patch test can be performed to check for any reactions.

Although the artist will take every care not to get glitter/glue tattoos on your clothes, if they do come into contact with glue/glitter they should be cold soaked and washed as normal. The artist cannot be held liable for any damage caused.

We will not apply glitter tattoos to children under the age of 3 years without parental consent.

Children over 3 years of age will only be painted at the artist's discretion and the artists' decision is final.

The artist will only apply glitter tattoos to children who are happily willing to participate. Any children that seem upset or worried will not have tattoos applied. Again, this is at the artists' discretion.

At all times, adult consent is required before children can have nail paint/glitter tattoos. At private parties, the host is responsible for informing the parents/guardians that our services will be available.

The host is also responsible for informing the artist of any children that cannot participate.

The glue should not be harmful. They are water resistant and with care can last 5 -7 days. Glitter Tattoos will hold up through regular bathing/showering provided there is no harsh scrubbing of the area. Harsh or excessive rubbing/scrubbing will remove glitter prematurely. Glitter Tattoos will usually just wear away after about a week, but if you should need to remove, this can be done using lotion, oil or rubbing alcohol and a cotton ball.
